

Constitution

Article I: Name

The name of this organization shall be the Disc Golf Club.

Article II: Purpose

The purpose of this club is to have a structured time for EMU students who enjoy disc golf and want to play with other students on campus. The group was founded to help spread the love of disc golf to the EMU students and faculty, to provide a platform where those of all skill levels can come and play, as well as give an opportunity for those who want to develop their disc golf game to come to do that and ask questions or get instruction from other disc golfers there.

Article III: Membership

Becoming a member involves approaching a club officer with intent to join the club. That club officer will add the interested student to the email list. Members have the right to come and go from the group as they please. Members may be removed if they are being a major distraction to the goals of the club or are causing too much of a problem when we gather. Before the removal of a club member, there will be a meeting between club officers to discuss the removal. EMU does not discriminate on the basis of race, color, national or ethnic origin, sex, disability, age, sexual orientation, gender identity or any legally protected status in any of its school administered.

Article IV: Officers

- I. Titles and duties of any club officer positions
 - A. (Co-)President(s): Oversee club
 - B. Event Coordinator: Plans events
 - C. Treasurer: Keeps track of budget in spreadsheet
- II. Any member of the EMU Disc Golf Club is eligible to become an officer. In the case of unexpected officer vacancies, the Co-President(s) fill the position with who they see best fit from within the membership of the EMU Disc Golf Club
- III. Removal from office:
 - A. If an officer is posing problems the members can vote to have them removed with a two-thirds vote. The officer who is potentially getting removed does not have a vote.
- IV. Officers will serve one year terms of service

Article V: Elections

Elections must be held in the spring of the year for the following year's officers. Any member of the club may submit their name for consideration to serve in any leadership position. Nominees will present their qualifications alongside others who are eligible to run for the given position. Positions will be filled by members filling out a nomination form. With a unanimous vote by the four officers, an applicant can get rejected if officers don't see the applicant as qualified. Elections will be determined by majority vote. Election results will be posted a week after elections take place. Members will be notified in an email sent to the club members.

Article VI: Meetings

- I. Members will meet once a week to play disc golf. Leadership meetings will happen once a month. The co-presidents will lead the meeting with what they see fit is needed to be talked about. Other officers or members can bring up things that need to be discussed as well.
 - A. Members will be notified of meetings
 - B. Meeting minutes will be sent to members via email
 - C. Every other month members are allowed to sit in on the meeting
- II. Organizational decisions making
 - A. The majority of decisions will be made by the club officers. The faculty advisor and members will be consulted on major decisions
 - B. Eligibility to vote and quorum: The club officers are eligible to vote and all officers need to be present for a vote.

Article VII: Finances

- I. Organization financing of activities: club activities will be free
- II. The organization will not submit an annual budget request to SGA
- III. Financial record keeping: google sheets
- IV. Responsibility for developing the budget: club officers along with the faculty advisor
- V. No dues will be required
- VI. Responsibility for the collection and disbursement of funds: Co-presidents
- VII. Authorization of expenditures: Co-presidents

Article VIII: Advisor

The advisor's role in the club is to help with decisions for the club whether it be financial or strategic decisions.

Article IX: Committees

Committees will not be necessary for this club.

Article X: Affiliations

The EMU Disc Golf club will cooperate with Roctown Disc Golf Club to advance the sport.

Article XI: Amendments

Amendments can be proposed by anyone and the club officers will review them and vote with a 75% vote needed to enact that constitutional amendment.

Article XII: Ratification

The club members will vote with a 75% vote needed to ratify the constitution.
